2018 Outstanding Law Enforcement Officers of the Year Awards

Arkansas Attorney General Leslie Rutledge is accepting nominations from college/university, municipal, county, state and federal law enforcement agencies for the 2018 Outstanding Law Enforcement Officers of the Year Awards. The selection process will be based on qualified candidates who have performed admirably in the line of duty within the past 18 months.

One winner will be selected from each of the state's 75 counties. Five regional winners will then be selected from county winners. The overall state officer of the year will be selected from among the regional winners.

County and regional winners will be selected by regional judging panels comprised of city, county and state criminal justice professionals. Each regional panel will consider nominees from a different region.

County and regional officers of the year will be honored at the Arkansas Law Enforcement Summit on October 2, 2018, at the Benton Event Center. The 2018 Arkansas Outstanding Law Enforcement Officer of the Year will be announced by Attorney General Rutledge at the Summit luncheon. Nominations must include a letter sharing details of the nominee's job performance. Letters should be limited to no more than two pages. Copies of background material, media clippings and a photograph may be attached. Please label the back of photographs with the nominee's name, rank and department.
